In the event my child suffers an illness or injury or requires emergency treatment during AWANA activities and I am unable or unavailable to provide immediate medical attention for my child, I authorize any licensed physician, dentist, emergency medical technician, hospital, or other healthcare facility to perform all procedures deemed medically advisable to treat my child's illness, injury, or pain.

It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care in order to permit Mililani Community Church (MCC) and its representatives, as my agent, to consent to any x-ray, examination, anesthesia, surgery, blood transfusion, medication, medical treatment, or hospital care deemed medically necessary.

I understand that I am responsible for providing medical insurance and payment of all charges incurred in diagnosis and treatment.

PARTICIPATION RELEASE AND COVENANT: I give consent for my child(ren) to participate in the AWANA activities of MCC. I assume all risks and hazards incidental to such participation, including transportation to and from the activities, and do hereby waive, release, absolve, indemnify, and agree to hold harmless MCC, MCC's successors and assigns, MCC's officers, directors, employees, members, representatives, and volunteers, including the AWANA staff, from all liability, claims, demands, causes of action, damages, costs, and fees (including attorneys' fees), both present or future and anticipated or unanticipated, which may arise from my child's participation in AWANA activities.

In the event that my child creates a discipline problem that cannot be reasonably corrected by those supervising the activity, I agree to go to the location of the activity and pick up the child or arrange satisfactory transportation from the activity.

PHOTOGRAPHIC / VIDEO / VOICE RECORDING CONSENT AND RELEASE:

- I grant to MCC and those acting for MCC the unrestricted right to use any photograph, video, film, image, likeness, slide, and/or voice recording (Materials) pertaining to me and/or my minor child(ren) while participating in AWANA activities. Such use may include publicity of AWANA events, display on bulletin boards, distribution through all media, incorporation in a video or film to be shown to MCC and other audiences, and posting on MCC's website. This grant includes the right to use, edit, mix, duplicate, and reuse the Materials, in whole or in part.

I acknowledge that MCC's use of the Materials confers no rights of ownership or royalties in me or my child(ren), and I hereby waive, for myself and/or my child(ren) listed above, all rights and objections associated with use of the Materials, including any reasonable expectation of privacy and confidentiality.

I understand that this consent is continuous and can only be rescinded in writing. I further understand that any written rescission of my consent shall not apply to Materials that have already been used, published, distributed, or posted.
